Subject:- Appointment of Lecturer 10+2 in the discipline of Physics in School Education Department.

Whereas, vide Letter No. PSC/DR/Lect. Physics/2016 dated 19.05.2017, J&K Public Service Commission has forwarded the select list of candidates for the posts of Lecturer 10+2 in the discipline of Physics in the School Education Department; and

Whereas, appointment orders were issued in respect of selected candidates as Lecturer (10+2) in the discipline of Physics in the School Education Department vide Government Order No. 294-Edu of 2017 dated 09.06.2017 and appointees were directed to report to the respective Directorates of School Education within 21 days, failing which their appointment will be treated as cancelled without any notice; and

Whereas, following candidates have failed to join in the Directorate of School Education, Kashmir/Jammu within the stipulated time period, despite issuing final notice through print media to the said candidates by the respective Directorates of School Education:-

1. Mr. Waseem Bashir S/o Mr. Bashir Ahmad R/o 121/1 (old) Rose Lane Colony Chanapora Lane-B P/O Natipora, Srinagar figuring at S.No. 11 under **OM** category.
2. Mr. Sachin Verma S/o Makhan Lal Verma R/o W.No. 4 NR Old Bus Stand Billawar figuring at S.No. 17 under **OM** Category.
3. Ms. Kunchok Norboo D/o Tsering Angchok R/o Village Neyraks Block Khalsi District Leh Khalsi figuring at S.No. 1 under **ST** category.

Whereas, due to non-joining of above candidates and after giving them final opportunity, their appointment as Lecturer 10+2 in the discipline of Physics in the School Education is required to be cancelled and the Administrative Department is required to operate the waiting lists of respective categories; and


