Subject: Placement of PG Masters as I/C Lecturers in the discipline of Stenography.

On the basis of seniority/ eligibility, the following twelve (12), PG Masters are hereby placed as I/C Lecturers in the discipline of **Stenography** in their own pay and grade, with charge allowance as admissible under rules, for a period of six months or till these posts are filled up on regular basis through PSC/ DPC, whichever is earlier:-

The placement of incumbents figuring at serial Nos.2, 3, 5, 6, 8, 10, 11 & 12 shall be subject to the qualifying the mandatory shorthand and type test in terms of existing Gazetted Recruitment Rules of School Education Department as they have not qualified the said test. The said test in respect of these candidates (who have not qualified the same), shall be conducted through concerned Directorate of School Education in terms of recruitment rules and in case they fail to qualify the same, their elevation shall be withdrawn without any further notice and next eligible candidate shall be considered for elevation.

The above placement, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any court case that may be sub-judice in the court(s) of Law. However, they shall be entitled to the charge allowance as admissible under rules.

The I/C Lecturers shall report to concerned Directorate of respective Divisions within 21 days from the date of issuance of this order. If any I/C Lecturer(s) fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- i) The bio-data/ service particulars of the promotees as mentioned against each.
- ii) The concerned Directorate of School Education shall conduct a short hand and type test of officials **except S.No.1, 4, 7 & 9** (mentioned above) in terms of existing Gazetted Recruitment rules before allowing them to join as I/C Lecturer (**Stenography**)
- iii) The claim of the senior (if any) shall be considered, by demoting the junior one.
- iv) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**Stenography**).
- v) That the in-service candidates who have acquired P.G Degree after availing the leave during his/her service and after obtaining the proper permission from the competent authority. In case during this verification, it is proved that they have failed to obtain the permission of competent authority or they had not availed proper leave/ permission, their officiating placement shall be deemed to have been cancelled ab-initio without any further notice. The Director School Education shall immediate revert him back to his original place of posting.
- vi) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid and validity of category certificate(s), if any, shall be determined by the concerned Directorate of School Education or any officer delegated to do so by the Director concerned;
- vii) The officer(s) is not involved in any adverse case(s) (Vigilance/ Crime etc) which fact shall be ascertained by the concerned Directorate of School Education.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and such cases shall be

referred to the Administrative Department for further action. Those officials, who fulfill the conditions and are allowed to join, be posted by the respective Directorates as per the transfer policy of the department.
