Regularization of S/Shri K.K. Sethi and Rajinder Singh, Lecturers (Mathematics).

## Government Order No. 73-Edu of 2017 D a t e d :- 27.02.2017

Whereas, vide Government Orders No.275-Edu of 2005 dated 30.08.2005 and 737-Edu of 2005 dated 25.10.2005 S/Shri Kamal Kishore Sethi and Rajinder Singh were regularized as Lecturers (Mathematics) notionally from 24.02.1988 and regular from 25.04.2003 respectively; and

Whereas, vide Government Order No.322-Edu of 2006 dated 23.06.2006 their regularization as Lecturer ordered vide aforesaid Government orders was withdrawn; and

Whereas, S/Shri Kamal Kishore Sethi and Rajinder Singh, Lecturers approached the Hon'ble Court and prayed for quashment of Government Order No.322-Edu of 2006 dated 23.05.2006; and

Whereas, the Hon'ble High Court while disposing of the writ petition on 27.02.2012 has passed the following orders:-

"So viewed, the petition is disposed of with a direction to the respondents to accord consideration to the case of petitioner No.1 and 3 for conferment of benefit as has been given to Petitioner No.2, in case, all the petitioners are similarly placed and are in terms of rules entitled to same treatment/benefit. The respondents shall take a decision in the matter within six weeks from the date copy of the order is served on them. The petitioners may if so advised, hand over copy of the petition alongwith all its annexures to the respondents, so as to facilitate an early decision in the matter."

Whereas, in view of court directions, the case was examined in this department and vide Government Order No.575-Edu of 2013 dated 30.05.2013, the sub paras ii, iii & iv of para 8 of Government Order No.322-Edu of 2006 dated 23.05.2006 has been deleted in which regularization of S/Shri K.K. Sethi and Rajinder Singh as Lecturer was withdrawn; and Whereas, S/Shri K.K. Sethi and Rajinder Singh represented this department with the plea that their regularization/confirmation order which was earlier withdrawn has now been cancelled ab-initio vide Govt. Order No: 575 Edu of 2013 dated: 30.05.2013 and has requested for further benefits with regards to fixation of seniority as Lecturers/ Senior Lecturers and placement of Senior Lecturers accordingly; and

Whereas, the case was further examined and on the basis of their dates of regularization as Lecturers notionally from 24.02.1988 and regular from 25.04.2003, and it has been found that the junior counterparts of Shri K.K. Sethi and Rajinder Singh, Lecturer (Mathematics) have been placed as Sr. Lecturer w.e.f 16.03.2005 and they too are eligible for the same treatment as has been given to their junior counterparts. Their seniority needs to be fixed at appropriate place in the seniority list of Lecturers available at that time and placement as Senior Lecturers as had been given to their counterparts, besides fixing their seniority as Senior lecturers at appropriate places on the basis of date of placement as Senior Lecturers.

Now therefore, in view of the above, sanction is hereby accorded

- i. inclusion of Shri Rajinder Singh and K.K. Sethi, Lecturer (Mathematics) at Srty. Nos. 733-A and 733-B respectively in the seniority list of +2 Lecturers issued vide Government Order No.350-Edu of 2003 dated 31.03.2003.
- ii. placement of S/Shri Rajinder Singh and K.K. Sethi, Lecturer (Mathematics) as Senior Lecturer w.e.f 16.03.2005 respectively.
- iii. inclusion of name of S/Shri Rajinder Singh and K.K. Sethi, Lecturers (Mathematics) at Sty. Nos.365-A and 365-B between Mrs. Devinder Kour and Shri Bansi Lal in the seniority list of Senior Lecturer issued vide Government Order No.270-Edu of 2013 dated 12.03.2013.
