Whereas, Jammu and Kashmir Public Service Commission, vide their communication No.PSC/DR/Lect.Dogri/2017 dated 16.04.2018, forwarded select list of candidates for the post of Lecturer 10+2 in the discipline of Dogri of School Education Department;

Whereas, on the basis of recommendations of J&K Public Service Commission, 03 (three) candidates were appointed as Lecturers 10+2 in the discipline of Dogri in the School Education Department vide Government Order No. 694-Edu of 2018 dated 21.05.2018; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within 21 days from the date of issuance of order failing which their appointment orders will be cancelled without any notice; and

Whereas, Mr. Sunil Dutt Sharma, S/o Sh. Krishan Lal Sharma, figuring at S.No.01 under OM category in the appointment order No.694-Edu of 2018 dated 21.05.2018, has failed to join in the Directorate of School Education, Jammu within the stipulated time period; and

Whereas, the candidate was given final opportunity by DSEJ vide No. No.DIP/J-2893/18 dated 23.06.2018, through print media in daily newspapers viz "Daily Excelsior" dated 24.06.2018 but the candidate failed to join in DSEJ; and

Whereas, due to non-joining of above candidate and after giving him final opportunity, his appointment as Lecturer 10+2 in the discipline of Dogri in the School Education Department is required to be cancelled as warranted under rules.

Now, therefore, the appointment of Mr. Sunil Dutt S/o Sh. Krishan Lal , R/o VPO Jandrah, Jandrah, Dansal figuring at S.No.01 under OM category as Lecturer 10+2 in the discipline of Dogri issued vide Government Order No. 694-Edu of 2018 dated 21.05.2018, shall and shall always be deemed to have been cancelled abinitio.
