WHEREAS, during the meeting the Hon'ble MLAs/MLCs raised the issue of having necessity of Urdu teachers in the elementary Schools, keeping in view of the official language of the State that Urdu language; and

WHEREAS, it was unanimously decided in the meeting to make teaching of Urdu language compulsory in both Government and Private Schools up to 5th standard in the State. This will be in addition to the teaching of Hindi, which is already a compulsory subject in Schools of Jammu Division; and
