Whereas the I/C Chairman/ Secretary JK BOSE, vide Communication No: F(PSS/CU)17, dated 14.08.2017, has forwarded two lists comprising Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class IV, forming Annexures A & B to this order, who were assigned duties as Superintendents/ Deputy Superintendents/ Assistant Superintendents in various Board examinations during session 2016-17 across the State and were found abetting in use of unfair means, thus violating the sanctity of the examinations; and

Whereas the aforesaid Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class IV were given opportunity of being heard to explain their positions, and thereafter their cases were referred to the Sub-Comittee of JK BOSE on Unfair Means, which after deliberating upon the matter in detail, found them guilty of resorting to unfair means; and

Whereas the Sub-Committee, after finding the aforesaid Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class IV, guilty, awarded punishment in their favour by debarring/ disqualifying them from taking Board/ invigilation assignments for violating the sanctity of the Board examinations: and

Whereas the matter has been referred to the Administrative Department and the Administrative Department, after examining the contents of the case, has found that these Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class IV have breached the trust reposed in them while working as Superintendents/ Deputy Superintendents/ Assistant Superintendents in various Board examinations during session 2016-17 and have indulged in acts which attract further punitive action, in terms of J&K Civil Services (Classification, Control and Appeal) Rules, 1956.

Now, therefore, it is hereby ordered that the Lecturers/ Masters/ Teachers/ Non-teaching staff/ Class IV, *indicated at Annexures A & B to this order*, are hereby placed under suspension with immediate effect. However, during their period of suspension, they shall report at their respective institutions where they are presently posted.
