WHEREAS, the Joint Secretary (Examinations), JKBOSE, Jammu Division *vide* No. JS (Exam-B) JD/18, dated 31.03.2018 has intimated about a incident of wrong opening of sealed packet of English paper of ongoing HSP-II Examinations (Class-12^{th)} Private, Bi-annual Session, 2018, Winter Zone, Jammu Division instead of English Paper of Secondary School Examination (Class-10th) Private, Bi-annual Session, 2018 winter Zone, Jammu Division at Centre No. 5102 constituted at HSS Batote, Ramban, which was conducted on 24.03.2018; and

WHEREAS, it has been reported that Superintendent of Centre No. 5102 (constituted at HSS Batote, Ramban) of Secondary School Examination (Class-10th) Private, Bi-annual Session, 2018, Winter Zone, Jammu Division, wrongly collected the sealed packet paper of Question paper of HSP-II Examination (Class-12th) Private, Bi-annual session, 2018, Winter Zone, Jammu Division from the Police Station concerned on 24.03.2018 and had put his signatures on outer cover of sealed packet without ascertaining the contents printed on the sealed packet, whether the same is meant for ongoing Class-12th Examination or ongoing Class-10th Examination, Bi-annual session, 2018, Winter Zone, Jammu Division. The same sealed packet paper was also signed by the Principal, HSS Batote, Ramban (Overall Incharge), Deputy Superintendent along with the Supervisors of the said centre and they too had not ascertained the contents of the said sealed packet. This reflects the sheer negligence on their part in discharging their sensitive nature of duty, thus putting the academic career of thousands of candidates in distress, besides caused a huge monetary loss to the exchequer of the BOSE, as fresh material has to be arranged for the said subject; and

WHEREAS, the Joint Secretary (Examinations) has requested for initiating appropriate administrative action against the defaulters for their grave negligence while conducting the above said examination, so that such negligence's are not repeated in future; and
