These I/C Lecturers shall report to their concerned Directorate within 21 days from the date of issuance of this order. If any of these P.G Masters fails to join within the stipulated time period, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education, Jammu will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotee as mentioned above.
- (ii) If the promotee is already working either as I/C Headmaster or I/C Lecturer in other disciplines he/she may not be allowed to join as I/C Lecturer (Sociology).
- (iii) That the mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The promotee is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.

The concerned Directorate of School Education, shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the case(s) shall be referred to the Administrative Department for further action.

Directorate School Education concerned after verifying the service particulars and fulfilling the above said conditions, shall post them in Zone —III/preferably against clear vacancies and against the longest staying candidates as per the requirement of the Department.
