Whereas, on the basis of Final Seniority List, placement orders in respect of 09 PG Masters as I/C Lecturer (Arabic) were issued vide Government Order No.1012-Edu of 2018 dated 15.12.2017 respectively; and

Whereas, among others, the placement of, Sty. No.40 PG Master, Mr. Qawam-

ud-Din was kept withheld for the reasons shown below against each:-

Whereas, the above Master has represented to this department alongwith relevant/deficient documents for issuance of placement order in his favour as I/C Lecturer on the plea that his Junior counterparts have been placed as I/C Lecturers; and

Whereas, the matter has been examined in the Administraive Department, and it has been decided to take a lenient view and consider the placement of Qawam-ud-din, Master as I/C Lecturer (Arabic) with the condition to grant post facto sanction of extra ordinary leave without pay for the period he has availed the leave.

Consequent upon above and in continuation to Government Order No.1012-Edu of 2017, dated 15.12.2017, Qawam-ud-Din, Master presently posted at M/S Raj Mohalla Zone Dangerpora District Baramulla is hereby placed as I/C Lecturer (Arabic) in his own pay and grade with charge allowance, as admissible under rules, for a period of six months or till the post is filled up on regular basis, whichever is earlier.

The above, placement, however, shall not confer any superior claim or right upon him at the time of his confirmation which shall be strictly, made as per Recrutiment Rules. The above placement shall also be subject to the outcome of any court case that may be sub-judice in the Court (s) of law.

The Incharge Lecturer shall report to Directorate of School Education, Kashmir within 21 days from the date of issuance of this order. If he fails to join within the stipulated



period of time, it shall be presumed that he has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The Directorate of School Education, Kashmir will allow him to join only after verifying the following:-

- (i) The bio-data/ service particulars of the I/C Lecturer as mentioned above.
- (ii) If the official is already working as I/C Headmaster or I/C Lecturer in any other disciplines he may not be allowed to join as I/C Lecturer Arabic).
- (iii) That the mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which acquired are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The official is not involved in any adverse case(s) (Vigilance/Crime etc) which shall be ascertained by the concerned Directorate of School Education Department.

The Directorate of School Education, Kashmir, shall ensure that all the above conditions are fulfilled by the official before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he will not be allowed to join and the case shall be referred to the Administrative Department for further action.
