**Subject:-** Cancellation of appointment of Mr. Bilal Ahmad Wani S/o Mohammad Maqbool Wani R/o Wani Mohalla Shar-i-Shali Pampore as Lecturer 10+2 in the discipline of Botany.

Whereas, Jammu and Kashmir Public Service Commission, vide their communication No. PSC/DR/Lect/Botany/2016, dated 16.08.2017, recommended a list of candidates for the post of Lecturer 10+2 in the discipline of **Botany** in School Education Department; and

Whereas, on the basis of recommendations of J&K Public Service Commission, 121 candidates were appointed as Lecturers 10+2 in the discipline of **Botany** in the School Education Department vide **Government Order No. 704-Edu of 2017 dated 03.10.2017**; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within 21 days from the date of issuance of the order, failing which their appointment would be cancelled without any notice; and

Whereas, Mr. Bilal Ahmad Wani S/o Mohammad Maqbool Wani R/o Wani Mohalla Shar-i-Shali Pampore, figuring at S.No. 11 under OM category in the Government Order No. 704-Edu of 2017 dated 03.10.2017, failed to join in the Directorate of School Education, Kashmir within the stipulated time period; and

Whereas, Directorate of School Education, Kashmir had given final opportunity to the above candidate to join within a week's time positively by issuance of notice through print media in daily newspaper viz. "Kashmir Uzma" on 11.11.2017, however, the said candidate again failed to join in the Directorate of School Education, Kashmir; and

Whereas, due to non-joining of above candidate and after giving him final opportunity, his appointment as Lecturer 10+2 in the discipline of Botany, in the School Education Department is required to be cancelled and the Administrative Department is required to operate the waiting list of the respective category.

Now, therefore, the appointment of Mr. Bilal Ahmad Wani S/o Mohammad Maqbool Wani R/o Wani Mohalla Shar-i-Shali Pampore, figuring at S.No.
