The terms of reference of the Committee shall be as under:-

- i. To examine the inspection reports of ETT institutions received from the inspection Committee constituted vide Government order No. 564-Edu of 2017 dated 22.8.2017,read with Government order No.973-Edu of 2017 dated 6.12.2017.
- ii. To examine the inspection reports in light of the orders passed by the Administrative Department from time to time and also in accordance with the Jammu and Kashmir, School Education Rules, amended from time to time.

- iii. To examine as to whether the calendar issued vide Government order dated 10.02.2011, requires any change or same be allowed to continue.
- iv. To submit the actionable points for taking further action in this matter.

The committee shall give recommendations on cases to case basis for submission to the higher authorities for approval. All process by the Committee must be completed by 15 October, 2018.
