Subject:- Appointment of Lecturer 10+2 in the discipline of Education in the School Education Department- cancellation of appointment orders thereof.

Whereas, Jammu and Kashmir Public Service Commission, vide their communication No. PSC/DR/Lect.Education/2016, dated 16.06.2017, forwarded select list of candidates for the post of Lecturer 10+2 in the discipline of Education of School Education Department; and

Whereas, on the basis of recommendations of J&K Public Service Commission, 45 candidates were appointment as Lecturers 10+2 in the discipline of Education in the School Education Department vide Government Order No. 474-Edu of 2017 dated 25-07-2017; and

Whereas, the appointees were directed to join/report to the concerned Directorate of School Education of respective Divisions within 21 days from the date of issuance of order, failing which their appointment orders will be cancelled without any notice; and

Whereas, following candidates figuring in the appointment order issued vide Government Order No. 474-Edu of 2017 dated 25-07-2017, have failed to join in the Directorate of School Education, Jammu within the stipulated time period:-

- i. Mr. Tilak Singh S/o Gain Singh R/o 113 Gurmul Dhandal Kashtigarh figuring at S.No. 9 under RBA Category.
- ii. Ms. Marriam D/o Mohd Yusaf W/o Gulshan Ahmad R/o Battal Ballian P/o Kharodian, Udhampur figuring at S.No. 2 under ST category.

Whereas, Directorate of School Education, Jammu had given final opportunity to respective candidates to join within a week's time positively by issuance of notice vide No. DIP/J-4490/17 dated 1908.2017 through print media in daily newspapers viz. "Daily Excelsior". However, they have again failed to join in the Directorate of School Education, Jammu.

Whereas, due to non-joining of above candidates and after giving them final opportunity, their appointment as Lecturer 10+2 in the discipline of Education in the School Education Department is required to be cancelled and the Administrative Department is required to operate the waiting lists of respective categories. The next candidates figuring in the waiting list of respective categories, as conveyed by PSC, are as given under:-

1. Mr. Zahoor Ahmad Bhat S/o Mohd Yousuf Bhat R/o Chitripora figuring at S.No. 1 under **RBA category** of the waiting list.
2. Mr. Bilal Ahmad Lone S/o Mohd Sultan Lone R/o Gund Gull Sheikh Gurez figuring at S.No. 1 under **ST category** of the waiting list.

Now, therefore, the appointment of the aforesaid candidates, namely, Mr. Tilak Singh S/o Gain Singh R/o 113 Gurmul Dhandal Kashtigarh figuring at S.No. 9 under RBA Category and Ms. Marriam D/o Mohd Yusaf W/o Gulshan Ahmad R/o Battal Ballian P/o Kharodian, Udampur figuring at S.No. 2 under ST category of the selection list, as Lecturer 10+2 in the discipline of Education, issued vide Government Order No. 474-Edu of 2017, dated 25-07-2017, shall and shall always be deemed to have been cancelled.

Consequent upon above, sanction is hereby accorded to the appointment of following candidates as Lecturer 10+2 in the discipline of Education in the School Education Department, in the pay scale of 9300-34800 plus Grade pay of Rs. 5400/-, strictly in terms of SRO-202 of 2015 dated 30.06.2015, by operating waiting list of respective categories:-

1. Mr. Zahoor Ahmad Bhat S/o Mohd Yousuf Bhat R/o Chitripora figuring at S.No. 1 under **RBA category** of the waiting list.
2. Mr. Bilal Ahmad Lone S/o Mohd Sultan Lone R/o Gund Gull Sheikh Gurez figuring at S.No. 1 under **ST category** of the waiting list.

The terms and conditions of the appointment of above candidates shall remain same as laid down in Government Order No. 474-Edu of 2017, dated 25-07-2017.


