The above appointments shall be governed by SRO-202 of 2015 dated: 30.06.2015. **The appointees figuring at S.No. 2, 3, 4, 6, 7 & 9 shall report in the Directorate of School Education, Kashmir and S. No. 1, 5 & 8 shall report in the Directorate of School Education Jammu. The concerned Director shall allow them to join only after verification of the following documents in original:-**

- Permanent Residence Certificate
- Age and Health Certificate
- Academic Qualification and Category Certificate (if any) and genuineness thereof.
- No Loan Certificate from DIC/concerned District Employment Office.
- Character/ antecedents certificates.

Handwritten signatures and initials at the bottom left of the page.

If on verification, the certificates produced by the appointee proved to be fake or forged, the appointment shall stand cancelled ab-initio.


**The appointment of above candidates shall further be subject to the following conditions:-**

- a. That the appointment of the selected candidate shall strictly be governed by Rule 8, 9, 10, 11 and 12 of SRO-202 OF 2015 dated 30.06.2015.
- b. That the appointee/s shall report within a period of 21 days from the date of issuance of this order, failing which their appointment will be treated as cancelled without any notice.
- c. The appointee shall have to necessarily work for a period of five (5) years on the post against which he/she has been appointed and such appointee shall not be eligible for transfer for whatsoever reason during the temporary service of five years.
- d. That any person appointed against any available vacancy on the basis of being a resident of backward area or an area adjoining Line of Actual Control shall serve in such area for a period of not less than seven (7) years.
- e. That in the matter of other conditions of service like age, qualification, discipline, conduct and other allied matters, a person appointed under these rules shall be governed by the recruitment rules of the service to which the post occupied by him belongs, besides, other rules, regulations and orders in vogue in the State Civil Services in general.
- f. That the salary of the above selected candidates shall not be drawn and disbursed unless and until his/her character/ antecedents are received from CID Headquarters and authentication of qualification / other allied documents from the concerned issuing agency / agencies.

The Director, School Education, Jammu/Kashmir, are directed to issue posting orders in respect of those appointees who join, immediately to ZONE-III areas as notified in Government Order No. 622-Edu of 2015 dated 22.12.2015 against available vacancies wherever these vacancies exist, and thereafter against those incumbents who are presently posted in ZONE-III areas beyond one year.

In case of non-joining of candidate(s) within 21 days, the Directorate of School Education Jammu/Kashmir shall give last and final opportunity to such candidate(s) by issuing notice through print/electronic media and report to the Administrative Department for operation of the waiting list.

The appointments shall also be subject to the outcome of the writ petition(s), if any, pending before Hon'ble Court of Law.
