Sanction is hereby accorded to the advance drawal of **Rs. 43.00 Cr. (Rupees forty three Crore only)** in favour of Director School Education Jammu /Kashmir ( Rs 21.50 crore to each) for further placement at the disposal of State Project Director Samagra Shiksha Abhiyan for upgradation of High Schools/ Higher Secondary Schools out of the capex budget 2018-19.

**The advance drawal shall be subject to the following conditions:**

- i) That Chief Accounts Officers of Director School Education Jammu/Kashmir shall vouchsafe availability of funds under the relevant account head for the purpose they are meant for.
- ii) That the expenditure shall be booked after observing all codal formalities and following due tendering process as provided in the rules to arrive at the reasonable and competitive rates.
- iii) That there should be no diversion of funds in any case.
- iv) That UCs / Red DC Accounts of the funds released shall be furnished to all the concerned quarters within the stipulated time but well before 31.3.2019.
