Regularization of drop out I/C Lecturers as Lecturers of different

disciplines of School Education Department.

Whereas, regularization of drop out cases of I/C Lecturers of different discipline of School Education Department were placed before General Administration Department for seeking one time dispensation of Competent Authority, effecting their regularization/ confirmation as I/C Lecturer from the dates they were holding the post on officiating basis; and

Whereas, State Cabinet vide its Decision No.225/ 26/ 2011 dated 16.12.2011 was conveyed its approval as under:-

"The proposal was approved as an exception. A Committee comprising the Commissioner/ Secretary, School Education Department, Commissioner Secretary General Administration Department (or his representative), Director, School Education, Kashmir and Director, School Education Jammu may scrutinize the case before the orders of regularization are issued."

Whereas, pursuant to the Cabinet Decision, a Committee of officers was constituted vide Government Order No.73-Edu of 2012 dated 04.02.2012 read with corrigendum dated 15.02.2012 for purposes of regularization of officers of the School Education Department.

Whereas, on the recommendation of said Designated Committee various I/C Lecturers were regularized as Lecturers in different disciplines during the year 2013 vide different Government Orders; and

Whereas, after issuance of regularization orders of Lecturers, the School Education Department has received various drop-out cases of I/C Lecturers for their regularization as Lecturer of different disciplines from concerned Directorate of School Education, from time to time; and

Whereas, such cases were scrutinized and examined in detail and accordingly, a joint proposal for their regularization of I/C Lecturers as Lecturers of different discipline was placed before the Designated Committee, constituted vide Government Order 70.73-Edu of 2012 dated 04.02.2012.

Whereas, the designate Committee in its meeting held on 28.01.2016 under the Chairmanship of the Principal Secretary to the Government, School Education Department has decided to settle the claim for regularization of 18 Lecturers of different

disciplines as per detail in **Annexure-A** from different dates as they were eligible for regularization (both notional and regular). The Committee, however, observed that the settlement of their claims needs availability of vacancies at relevant point of time, which are presently not available with the Department. Therefore, it was decided that their cases should be referred to the Finance Department for creation of supernumerary posts of Lecturers for the period mentioned against each, in relaxation of rules.

Whereas, accordingly, the cases were referred to the Finance Department for creation of supernumerary posts from different dates for settlement of the claim of these I/C Lecturers. The Finance Department vide their U.O.No.A/ 59 (2008)-Temp-602 dated 07.08.2017 conveyed the agreement to the departmental proposal to consider the promotion/regularization of superseded I/C Lecturers against the vacancies as were available even under direct recruitment quota on the respective dates to enable the department to redress the grievances of the superseded senior officials/officers.

Now, therefore, sanction is hereby accorded to the regularization of **eighteen (18)** I/C Lecturers as Lecturers of different discipline as per **Annexure-A** to this order in the relevant pay scale (as revised from time to time), for the period shown against each.

The above regularization shall be without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.

The Director, School Education, Jammu shall ensure that the regularization of the above incumbent shall be effected only after fulfilling the following conditions:-

- (i) The regularization is made strictly against available vacancies ever under direct recruitment quota on respective dates as per the agreement of the Finance Department.
- that the mode of acquiring degree (i.e. 10+2+2 (Bridge Course)/10+2+3) as well as the genuineness of P.G. certificate/ Institutions from which degree has been acquired is valid and validity of category certificate, if any, shall be determined by the concerned Drawing & Disbursing Officers before fixing his/her pay and if on verification, the certificate(s) produced by the Lecturer are proved fake or forged, the regularization shall be treated cancelled ab-initio.
- the Drawing & Disbursing Officer shall take an undertaking in a shape of an affidavit duly attested by the 1<sup>st</sup> Class Magistrate from the concerned Lecturers to the effect that if his service particulars/ PG Certificate is proved to fake/ forged/ tempered or issued by un-recognized University or the course itself is proved as un-recognized, he shall have no claim for the regularization and the regularization order issued in his favour be treated as cancelled ab-initio without further notice.
- (iv) that the concerned have acquired P.G. Degree after availing leave during his studies / obtained proper permission, as the case may be.
- the Drawing & Disbursing Officer concerned before fixing the pay of the Lecturer in the relevant pay scales as revised from time to time will obtain LPC and other related details (i, ii & iii above) from the Drawing & Disbursing Officers of their parent Institutions.

(vi) the regularization is without prejudice to the outcome of any writ petition pending in any competent court (s) of law or any case pending in Vigilance or Crime Branch.

The Drawing & Disbursing Officer shall be responsible for implementation/fulfillment of above conditions in letter and spirit.
