Whereas the petitioner was working as Data Entry Operator at ZEO Office, Was Data Entry Operator at ZEO Office, Was transferred vide Order No. 65 Ujala of 2017 dated 25 14 25 to ZEO Office Gragwal, District Samba; and

Whereas the petitioner approached the Hon'ble High Court through the measure of SMP No. 1040/2017 titled Rajiv Kumar V/8 State and others with the plea that Croster No. EduiSPD/SSA/drouter/11317-43/14 dated 27.08.2014, provides that the contractual amplicyess appointed under SSA at a particular place do not have transferable service; and

TRANSS, the HOUSE High Court vide its order dated 29.04.2017 disposed of the wife patition, the systative part of the order is reproduced as under:-

Whereas, the petitioner filed representation before State Project Director, Sarva Shiksha Abhiyan for modification of his order and requested for transfer to a nearer place of posting from his residence i.e. Vijaypur; and

Whereas, representation of the petitioner was examined and it revealed that the Sarva Shiksha Abhiyan being a Centrally Flagship Programme and the employees of the SSA are governed by the J&K Ujala Society (The State Implementation for Sarva Shiksha Abhiyan) Service Regulations, 2005. The Rule 5 (I) of the Regulations provides as under:-

"A member of service engaged either on contract basis or on deputation shall be liable be posted anywhere within the state of Jammu & Kashmir or in any other department of government, corporate body, society in the affairs of which the Society may have interest and in such cases, the member shall have no option against such posting or transfer".

Whereas, the Service Regulation 2005 has overriding effect on any circular, issued by the State Project Director, Sarva Shiksha Abhiyan and it does not create any right upon the petitioner for being posted at a particular place of choice; and

Whereas, the issue of transfer and postings has been considered time and again by this court and the Apex Court, and the entire law is settled by catena of decision of the Apex Court. It is settled law that transfer of a Government servant appointed to a particular cadre of transferable post from one place to the other is an incident of service. No Government servant, therefore, has any legal right for being posted at any particular place. Moreover transfer from one place to other is necessary in public interest and exigency of public administration as held in "Gujrat Electricity Board Vs Atma Ram Sugomal Poshani", AIR 1989 SC 1433, which reads as under:-

"An employee holding a transferable post cannot claim any vested right to work on a particular place as the transfer order does not affect any of his legal rights and Court cannot interfere with a transfer/posting which is made in public interest or on administrative exigency."

Now, therefore, the representation of the petitioner has been considered in light of the directions of the Hon'ble Court issued on 29.04.2017, and found devoid of merit and hence rejected.
