Subject: Placement of PG Masters as I/C Lecturers in the discipline of English.

Whereas, vide Government Order No.903-Edu of 2017 dated 26.10.2017, 47, PG Masters have been placed as I/C Lecturers in the discipline of **English**; and

Whereas, among others, the placement of following five (5) PG Masters to the post of I/C Lecturer (English) had been kept withheld for the reason as shown against each below:-

Whereas, the aforesaid PG Masters have represented before the Administrative Department alongwith relevant documents for consideration of their placement as I/C Lecturer (English) on the plea that they have been droped from elevation list and their juniors have been placed as such; and

Whereas, after examining the matter in detail, the School Education Department, has decided to release the placement of above-named PG Masters as I/C Lecturer (English) after according *post facto* permission for acquiring PG (English) in their favour and also grant of Extraordinary Leave without pay in their favour for the period while in service they have remained on leave for acquiring PG Degree (English); and

Now, therefore, post-facto sanction is hereby accorded to the grant of permission to acquire PG Degree in English from the concerned Universities in favour of above named 5 PG Masters, and sanction is also accorded to the extraordinary leave without pay in their favour for the period they have remained on leave for acquiring PG Degrees through concerned Universities; and

As a consequence, on the basis of seniority/ eligibility, the following five (5) PG Masters are hereby placed as I/C Lecturers in the discipline of **English** in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled up on regular basis, whichever is earlier:-

These placements, however, shall not confer any superior claim or right upon them at the time of their confirmation and shall also be subject to the outcome of any writ petition that may be sub-judice in the court(s) of Law.

The I/C Lecturers shall report to concerned Directorate of respective divisions within 21 days from the date of issuance of this order. If any I/C Lecturer(s) fails to join within the stipulated period of time, it shall be presumed that he/she has foregone the elevation and his/her placement as I/C Lecturer shall be withdrawn without any further notice.

The concerned Directorate of School Education will allow them to join only after verifying the following:-

- (i) The bio-data/ service particulars of the promotees as mentioned against each.
- (ii) Any of the promotee who has already been working either as I/C Headmaster or I/C Lecturer in other discipline may not be allowed to join as I/C Lecturer (**English**) and Adm. Deptt shall be informed accordingly.
- (iii) The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as the genuineness of P.G. Certificates/Institutions from which he/she has acquired such degree are valid, shall be determined by the concerned Directorate of School Education.
- (iv) The officer(s) is not involved in any adverse case(s) (Vigilance/Crime etc) which fact shall be ascertained by the concerned Directorate of School Education Department.
- (v) The placement is without prejudice to the outcome of any writ petition pending in any competent court(s) of law or any case pending in Vigilance or Crime Branch.

The concerned Directorate of School Education Department shall ensure that all the above conditions are fulfilled by the official (Promotee) before he/she actually joins in the Directorate. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and such cases shall be referred to the Administrative Department for further action.
