Whereas vide Government order No.181-EDU of 2017 dated 21.04.2017, NOC was granted in favour of 16 ETT Institutes available at Annexure-A to offer two year Diploma Course for the session 2017-19.

Whereas, the said NOC was granted on the basis of the recommendations of the Committee constituted vide Government order No.806-EDU of 2014 dated 04.12.2014 and clearance received from Crime Branch, Jammu vide No.CBJ/Legal/2016/193/10-12 dated 26.10.2016.

Whereas, a number of representations from Principals/ Officials of these Institutes have been received for renewal/extension of NOC for the session 2018-2020.

Whereas, all these representations were examined by the Committee constituted vide Government Order No.886-EDU of 2018 dated 11.10.2018.

Whereas, on examination of each representation, the committee found that reports of inspection teams constituted vide Government order No.181-EDU of 2017, dated 21.04.2017 referred to above were not available with the documents produced before the committee.

Whereas, on recommendations of the Committee, the matter was taken up with the J&KBOSE for providing the inspection reports of the inspecting team and other allied reports / documents.

Whereas, the Principals/Heads of all these 16 Institutes were also asked to submit affidavit to the extent that respective Institutes shall strictly comply with the norms of attendance of J&K BOSE and shall ensure that all norms with regard to teaching practices, inter-Institute functions etc shall be followed strictly.

Whereas, Joint Director, JKBOSE vide his No.F(D.EL.Ed/Acad/Insp/Rep/17-19), dated 26.11.2018, has sent the requisite documents.

Whereas, the inspection reports of the inspecting teams of J&K BOSE have been found satisfactory.

Now, in view of above and also keeping in view the earlier recommendations of the committee constituted vide Government Order No..806-EDU of 2014, dated 04.12.2014, Sanction is hereby accorded to the renewal of NOC in favour of ETT Institutes listed in Annexure-A to offer two year ETT Diploma course for the session 2018-2020.

All terms & conditions shall remain same as contained in Government order No.181-EDU of 2017 dated 21.11.2017 read with corrigendum issued under endorsement No.EDU/L/J/540/2014-IV dated 18.05.2017. Further, the detailed terms and conditions for functioning of these ETT Institutes shall be notified by J&K BOSE as per their rules & regulations.


