Contempt No. 724/2017 in SWP No. 56/2016 titled Mushtaq Ahmad Banday V/s State and others.

Government Order No.961 - Edu of 2018

Dated. 19.12.2018

Whereas, Mr. Mushtaq Ahmad Banday, Sr. Lecturer (Geography) filed writ petition bearing SWP No. 56/2017 titled Mushtaq Ahmad Banday V/s State and others before Hon'ble High Court with a prayer to grant retrospective effect of promotion alongwith all service benefits since 1994 as has been done in case of junior i.e Mr. Abdul Rashid Bhat and others; and

Whereas, the Hon'ble High Court disposed of the writ petition vide order dated 18.07.2018, the operative part of which is reproduced as under:-

"Disposed of with a direction to the respondents to consider the case of the petitioner in light of the representation which he shall file within one week"

Whereas, the case was under examination in the department the petitioner initiated contempt proceedings by filing Contempt Petition bearing No. 724/2017 against the department (Respondent). The Hon'ble High Court passed an order dated 25.10.2017 on the petition, the operative part of which is reproduced as under:-

"Notice to the respondents for filing statement of facts within two weeks"

Whereas the case has been examined in the department and it has been found that the petitioner now contemnor was appointed as teacher on 04.08.1980, promoted as Master on 28.11.1996, acquired Post Graduate degree in Geography in the year 1994 and was promoted as lecturer on substantive basis vide Govt. Order No. 1361-Edu of 1999 dated 29.10.1999 (prospectively from the date he join as such) as per the eligibility criteria and availability of vacancy at that time. While as Mr. Abdul Rashid Bhat was appointed as teacher on 01.03.1978, acquired PG degree in the discipline of geography 28.12.1982, after fulfilling the eligibility was placed as I/c lecturer on 08.01.1993 and thereafter was regularized/confirmed vide G.O No. 740-Edu of 1999 dated 20.05.1999 read with G.O No. 1147-Edu of 1999 dated from 08.01.1993 i.e after nine years of completion of his PG degree as per the packancy, eligibility criteria at that time.

Whereas, the detail of service particulars of Mr. Abdul Rashid Bhat and Mushtaq Ahmad Banday (Petitioner now contemnor) are as under:-

Whereas, the mode of recruitment to the post lecturer at that time as notified vide SRO-83 of 1992 dated 07.04.1992 is as under:-

"50% by direct recruitment.

50% by promotion from Masters in grade of 1300-2500 and in case candidate is available from Masters grade then by promotion from Sr. Teachers (1075-2320) and if no suitable candidate is available then by promotion General Line Teachers (900-1830) with at least 3 years experience as teacher"

Whereas, the case has been examined in the department as per the relevant recruitment rules and it has been found that at the time of elevation of Mr. Abdul Rashid Bhat, the then Teacher as lecturer, the petitioner now contemnor was not eligible for promotion as lecturer and was rightly elevated as lecturer on prospective basis vide G.O No. 1361-Edu of 1999 dated 29.10.1999 as per the eligibility criteria and availability of the vacancy by the DPC at that time.

In view of the above, the plea for grant of retrospective effect in promotion of the petitioner (now contemnor) on the analogy of Mr. Abdul Rashid does not merit consideration and the claim of the petitioner has been considered and is hereby rejected henceforth.
