Subject: Annual Transfer Drive (ATD-2022) of Lecturer cadre-reg.  
Ref: Notification No. 01-JK(EDU) of 2022 dated 09.02.2022.

Attention of all concerned is invited to the following points

1. The School education Department has adopted an online mode to facilitate the transfer of lecturers for their convenient/suitable postings.
2. The Department received online transfer requests from the Lecturers which were further processed through an online based software subject to their choices, availability of clear and deemed vacancy etc
3. However, due to negligence on the behalf of lecturers or CPIS errors or otherwise, those who are retiring within a year have been displaced vide various notifications under ATD-2022 Phase-I, for reasons therein, and were asked to apply again in Phase-II for their further postings
4. Subsequently, few representations and requests were received in the Department from the lecturers, placed under displaced category, to retain them at their present place of posting in view of their retirement in 2022- 2023.
5. In many instances similar cases were forwarded by the Director(s) School Education for consideration.
6. Accordingly, such requests and representations were examined in the Department and brought into the notice of competent authority.


Now, therefore, through the medium of this circular it is impressed upon all concerned:

(1)

- a) That all such lecturers, in the displaced category, retiring by **January 31<sup>st</sup> 2023** shall stay at their current place of posting till their retirement.
- b) The lecturers who have been transferred and posted at their places, at (a) above, shall also stay at their present place of posting till the incumbent therein vacates the post on retirement, not later than **January 31<sup>st</sup> 2023**.
- c) In case of lecturers whose current place of post has been allotted to some other lecturer in ATD -2022; they shall move to the new place of posting after ATD - Phase II.
- d) The salary issue arising due to the instructions at (c) above shall be resolved by the respective Directors, J&K, by drawing the salaries of the lecturers from the overall vacant posts of lecturers in above subjects firstly in the district or otherwise from the Division.

Further, the concerned HOIs/ DDOs shall bring all such cases and orders, thus issued, into the notice of the Administrative Department. A copy of the same also be forwarded on the mail id: [atdsed2022@yahoo.com](mailto:atdsed2022@yahoo.com) .
