- 1/ Whereas, the J&K Services Selection Board issued final select list of the candidates for the post of "**Junior Librarian**" (School Education Department) pursuant to Advertisement Notification No. 02 of 2017 under item No. 106 and recommended the same to the School Education Department vide letter No.SSB/Secy/Sel/2018/5788-95 dated 06.06.2018; and
- 2/ Whereas, the recommendation in respect of candidates namely **Sheikh Hujatul Islam S/o Gh Nabi Sheikh and Bilal Ahmad Mir S/o Ab Rashed Mir figuring at S.No. 02 and 03 under open merit** were kept withheld subject to production of bonafide certificate in respect of B.Lis degree; and
- 3/ Whereas, these candidates have furnished the bonafide certificates in respect of B.Lis degrees for release of their withheld recommendation wherein it has been found that the said candidates have pursued their degrees through regular mode in the year 2016 from Himalayan University Itanagar, Arunachal Pradesh; and
- 4/ Whereas, the case was processed in the Board for release of withheld recommendation and in the meantime the Board has received a compliant from some candidates agitating therein that the bonafide certificates submitted by the above said candidates are fraud as these candidates were working in different Government Deaprtments during the said period in J&K State as they have obtained their service record from the said departments through RTI; and
- 5/ Whereas, the information collected by the compliantants through RTI as well as Bonafide certificates furnished by the above said candidates have been forwarded to the concerned quarter viz Assistant Executive Engineer (PHE) Sub Division Kulgam, Principal Boys Higher Secondary School Arreh Kulgam and Registrar Himalayan University, Itanagar Arunachal Pradesh for authentication of the same; and


