Subject: Permission to collect September-October, 2014 Fee.

Some Schools functioning in the Valley have applied to this Committee for permission to collect fees from the students studying in the schools, for the months of September-October, 2014.

In PIL No.11/2015 a Division Bench of the Hon'ble High Court of Jammu & Kashmir directed all schools of the State not to charge fees from the students for the said months as the floods at various places in the State had paralyzed the normal functioning of the schools. The Hon'ble Court, however, gave liberty to these schools to approach this Committee for permission to collect the fees.

Vide this Committee Notice dated 14.09.2015 the schools were asked to apply to this Committee on a prescribed proforma.

Some Schools applied for permission on the said proforma and have submitted requisite certificates along with the cases.

The matter was got examined and enquired into by the Director, School Education, Kashmir. The Director constituted a Committee at the District level for this purpose comprising of:-

1. District Education Planning Officer/or Deputy Chief Education Officer;


2. Principal Higher Secondary School/Cluster Head;
3. Naib Tehsildar Concerned

The Director has furnished the report which shows that the schools, as shown in Annexure-I were not situated in the flood hit area and that the schools were functioning normally during September-October, 2014.

In view of the report, the applications of the schools, as given in Annexure-I are allowed and the schools are permitted to collect September-October, 2014 fee from the students.

The cases of other Schools are under active consideration and will be decided shortly.


