

The appointment shall be subject to the following conditions: -

- i) The appointees/selectee shall be on probation for a period of five years.
- ii) The appointees shall be governed under New Pension Scheme as per SRO 400 of 2009 dated 24.12.2009.
- iii) In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceeding shall be initiated against the candidate.

- iv) The selectee shall give an undertaking by way of an affidavit duly attested by the 1<sup>st</sup> Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- v) The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.
