The appointment of the above candidates shall further be subject to the following conditions:

a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the verification rolls (V-rolls), as available through the online mode under the Electronic Employment Verification System (EVS). Any submitted electronically shall result in cancellation of appointment without any further notice.

- b. Each appointee shall furnish an undertaking in the shape of an Affidavit as per Annexure-A to this Order.
- c. The salary of the appointee(s) shall not be drawn and disbursed to them unless satisfactory report in respect of genuineness of qualification/date of Birth/relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
- d. The appointees shall be on probation for a period of two years.
