Subject:- Re-fixation of seniority of +2 Lecturers of School Education Department.

Whereas, vide Government Order No.1073-Edu of 2013 dated 30.12.2013, updated seniority list of +2 Lecturers of School Education Department was issued, wherein Shri Brahm Rattan (RBA), Lecturer Zoology, is figuring at seniority No. 1575 on the basis of his earlier regularization as Lecturer w.e.f. 13.05.2008 ordered vide Government Order No. 47-Edu of 2013, dated 14.01.2013;

Whereas, vide Government Order No.924-Edu of 2017 dated 19.11.2017, among others regularization effect as Lecturer in favour of Shri Brahm Rattan Sharma, Lecturer (Zoology) has been modified as: w.e.f. 16.11.2005 on notional basis and on regular basis from 05.10.2007;

Whereas, Shri Brahm Rattan Sharma, Lecturer (Zoology) has represented to this department for re-fixation of his seniority in the cadre of Lecturer on the basis of his regularization effected from earlier date i.e. 16.11.2005; on the basis of Government Order No. 924-Edu of 2017 dated 19.11.2017;

Whereas, the case was examined in the Department, and a notice vide No. EDU/V/176/2017 dated 15.01.2018 was issued for seeking objections from members of the service, who were likely to be affected due to assigning of appropriate place to Shri Brahm Rattan (RBA), Lecturer Zoology at Sty No. 1089-A instead of Sty. 1575 in view of his promotion as Lecturer w.e.f 16.11.2005 in the final seniority list of Lecturers issued vide Government Order No.1073-Edu of 2017 dated 30.12.2017;

Whereas, Directors of School Education Jammu/Kashmir were requested to intimate whether any objection had been received with regard to re-fixation of seniority of Shri Brahm Rattan (RBA), Lecturer Zoology at Sty No. 1089-A instead of Sty.1575 in view of promotion as Lecturer w.e.f 16.11.2005 in the final seniority list of Lecturer issued vide Government Order No. 1073-Edu of 2017 dated 30.12.2017;

Whereas, No objection regarding re-fixation of Sh. Brahm Rattan Sharma was received from the Directorates; and



Whereas, in view of change in the date of regularization of Shri Brahm Rattan Sharma, Lecturer (Zoology) as 16.11.2005 on notional basis and 05.10.2007 on regular basis, he shall now figure at Seniority No.1089-A i.e. in between (Tej Pal Singh Seniority No. 1089) and (Mohammad Alam, Seniority No.1090) in the final seniority list of +2 Lecturers of School Education Department issued vide government Order No. 1073-Edu of 2013 dated 30.12.2013.

Now, therefore, the seniority of Shri Brahm Rattan Sharma is hereby re-fixed/fixed at 1089-A instead of 1575 in the Final Seniority List of +2 Lecturers of School Education issued vide Government Order No. 1073-Edu of 2013 dated 30.12.2013 with the following service particulars:-
