Withdrawal of placements in the discipline of Environmental Science in respect of Masters/Teachers who have obtained Post-Graduate Degrees through Distance Mode.

Government Order No. 2189 - JK (Edu) of 2022.

Dated: 16.12.2022.

Whereas, among others, the Department placed 72 Masters/Teachers as I/c Lecturers in the discipline of Environmental Sciences with purported PG Degree in Environmental Science / Ecology and Environment through Distance Mode from Institutions / Universities outside J&K vide Government Order No. 236-Edu of 2019 dated 15.07.2019, Government Order No. 252-Edu of 2019 dated 25.07.2019 read with Government Order No. 1071-Edu of 2022 dated 12.05.2022 & Government Order No. 325-Edu of 2019 dated 16.10.2019; and

Whereas, the above placement orders were subject to the conditions which are reproduced hereinbelow:-

- i. The Director School Education Jammu / Kashmir shall verify the Post Graduate Degrees obtained during service through Distance Mode in light of Government Order No. 940-Edu 2017 dated 17.11.2017 and shall allow such Masters/Teachers to join only when/if the PG Degrees are found genuine.
- iii. The Director School Education, Jammu / Kashmir shall allow them to join only after verifying the following:-
- c. The mode of acquiring degree (i.e. 10+2+2 with bridge course or 10+2+3) as well as genuineness of PG Certificates/Institutions from which he/she has acquired such degrees are valid.
- f. If any of the above mentioned conditions is not fulfilled by the official, he/she will not be allowed to join and the Directorate shall refer the case to the Administrative Department for further course of action within 30 days, from issuance of order.

Whereas, in light of Government Order No. 940-Edu of 2017 dated 17.11.2017, besides, satisfying the conditions laid down in in the said Government Order, concerned Directors must furnish clear cut recommendations, whether the candidates are eligible for inclusion in seniority / promotion; and

Whereas, in compliance with the above conditions and in response to the letter No. Edu-HRM/343/2022-01-SED (7047558), dated 20.10.2022, the recommendations furnished by the Director School Education Kashmir reveals that the candidates mentioned in the Annexure-A do not fulfill the conditions as laid down in Government Order No. 940-Edu of 2017 dated 17.11.2017; and

Whereas, the recommendations of Director School Education Kashmir in respect of candidates in Annexure-B reflect that equivalence of subject/course is required; and



Whereas, the communication received from University of Kashmir vide No. PB-917/EnvSc dated 11.10.2013 and University of Jammu vide No. F.Acd/III/22/6966 dated 28.09.2022 the degree obtained in Ecology and Environment through distance mode from different Universities outside UT of J&K cannot be given equivalence with M. Sc. Environment Science obtained from Kashmir University / Jammu University; and

Whereas, as per the recommendations furnished by Director School Education, Jammu reveals the candidates mentioned in Annexure-C do not meet out the requirements as per the conditions laid down in relevant Government Orders; and

Whereas, as per the information submitted by Director School Education, Jammu in respect of the candidates in Annexure-D, the permission for undergoing PG Degree is granted by either DSE Jammu / CEO concerned who are not competent authorities;

Whereas, the Department received significant number of representations from various quarters/cadre members challenging the placement/posting of Masters/Teachers as I/c Lecturers who have acquired PG Degree in Science stream through distance mode; and

Whereas, the Department examined and analysed the issues pertaining to placement/promotion of candidates who have obtained PG Degree in Science Stream through distance mode in light of relevant Government Orders, opinion received from concerned Universities and judgements passed by Hon'ble Courts; and

Whereas, in terms of Cabinet Decision No. 104/14/2012 dated 16.05.2012 issued vide Government Order No. 252-HE of 2012 dated 30.05.2012, in case of any dispute with regard to the equivalence of degrees, the issue has to be taken up with the State Universities for clarification and for drawing equivalence in this regard whose decision in that case shall be final; and

Whereas, in terms of the above referred Government Order the issue with regard to the equivalence of Degree obtained in Ecology and Environment and the Degree obtained in Environmental Science was taken up with University of Kashmir. In this regard, Dean Academics, University of Kashmir has examined the issue and accordingly following decision was conveyed to this Department vide communication No. PB No. 917/EnvSc dated 11.10.2013:-

"...that the PG in Ecology and Environment is a Distance mode degree through franchises and is not equivalent to the corresponding degrees of PG Environmental Science, University of Kashmir Srinagar and hence is not recognised by the University. That the PG degree in Environmental Science falls in the science stream (Faculty of physical and material science) where lab oriented and field practical form the core part of the curriculum which is lacking in the distance mode degrees. That neither the University of Kashmir nor University of Jammu recognises/ or gives equivalence to the distance mode degrees

recognises/ or gives equivalence to the distance mode degrees awarded outside J&K except through IGNOU, DOEACC and MANU. Hence in light of the above mentioned facts, it is clearly evident from the records and rules that the distance mode degree of PG in Ecology and Environment is neither recognised by the University



nor equivalent to the corresponding P.G. Degree of Environmental Science, University of Kashmir, Srinagar."

Whereas, the issue regarding equivalence of Post Graduate Degree in Ecology and Environment with that of Post Graduate Degree in Environmental Science was also taken up with University of Jammu. In response to the said referral, the University of Jammu vide its letter No. F.Acd/III/22/6966 dated 28.09.2022 has informed as under:-

"The post-Graduation Degree in Ecology and Environment obtained through Distance Mode from different Universities outside UT of Jammu and Kashmir cannot be given equivalence with that of Post-Graduate Degree through regular mode in Environmental Science awarded by University of Jammu."

Whereas, the issue regarding equivalence of degree with regard to Ecology and Environment with the Environmental Sciences has also been settled by the Hon'ble High Court of J&K in SWP 854/2010 titled Intiyaz Ahmad Bhat Vs State of J&K and Ors wherein the Hon'ble Court was pleased to dismiss the said writ petition vide its judgment dated 12.06.2012 with the following observation/direction:-

Articles 226 & 16 - Writ of mandamus - To accept and entertain degrees obtained through Distance Mode from unrecognized universities - Sought by the petitioner commanding respondents to accept and entertain Degrees of Master of Science/M. Phil obtained through Distance Mode from unrecognized Universities for purposes of employment - Decision of State Higher Education Department pursuant to reference made by Public Service Commission that decision of the University in case of any disputed degrees shall be final -- Decision not challenged in writ petition - Petitioners did not produce any document to show that their degrees are recognized in terms of University Grants Commission Act or any decision of J&K Higher Education Department - Writ petition dismissed in limine.

Whereas, judgment dated 12.06.2012 was assailed by the petitioner in Letter Patents Appeal (LPA No. 128/2012) before the Hon'ble Division Bench and the Hon'ble Court was pleased to dismiss the said Appeal being meritless vide order dated 24.8.2012; and

Whereas, the issue regarding validity of degree acquired through distance mode was taken up with the University of Kashmir and in response, the Department was conveyed as under:-

"...The University in this regard has categorically communicated the decision regarding the distance mode degree from time to time and in the latest communiqué No. FSPA/DAA/KU/2010 Dated March 10 2013 from Dean Academics Affairs office, Wherein it has been resolved by the high level committee that candidates holding Master's degree in science subjects awarded through the distance mode from other universities are neither eligible for appointment as lecturers in the Higher Education Department/ +2 level nor for admissions to the M.Phill / Ph.D. programme as the laboratory component which forms an indispensable part of the curriculum and requires a continuous guidance for the whole period of 4



semesters, is not given its due importance in the distance mode learning...

...Hence in light of the above mentioned facts, it is clearly evident from the records and rules that the distance mode degree of PG in Ecology and Environment is neither recognised by the University nor equivalent to the corresponding P.G. Degree of Environmental Science, University of Kashmir, Srinagar."

Whereas, the equivalence Committee of University of Kashmir constituted for the purposes of considering grant of recognition of such degrees through distance mode resolved as under on 10.04.2008:

"That recognition be granted to the Masters/Bachelor's degree in Arts, Social Science/Commerce obtained by the candidates through Distance mode from the Universities/Institutions recognized by the University Grants Commission and approved by the Distance Education Council, except the courses where practicals are involved.

Whereas, Ministry of Human Resource Development Department of Higher Education, New Delhi, have clarified the position regarding the recognition of academic qualifications acquired through distance mode and their acceptance for the purpose of employment in Central/State Government services, the relevant paragraph whereof is reproduced as under:

It is upto the concerned academic Institution/University to recognize the qualification including certificate, diploma, degree etc. for the purpose of academic pursuit i.e. continuing education for acquiring another academic qualification, with it. As regards, recognition of academic qualifications for the purpose of employment, it is the prerogative of concerned employer to take a view on the recognition of the degree, diploma etc."

Whereas, in *Bilal Ahmad Najar Vs State of J&K and Ors 2010* (2) *JKJ 218: 2009 (2) SriLJ 798* the Hon'ble High Court of J&K has held that degree obtained through distance mode and not recognized by University of Kashmir or by State Government being a degree not recognized by University of Kashmir cannot be treated a valid degree and does not confer any benefit upon the petitioner; and

Whereas, in Muzaffar Zaman Shah Vs State of J&K and Ors 2012 (3) JKJ 267: 2012 (18) SCT 357 the Hon'ble High Court of J&K observed as:- Degrees obtained through DistanceMode - Petitions challenging non-consideration of petitioners for various posts under the State or giving weightage to their degrees issued by various universities by distancemode - List of universities recognized with DEC placed on record - None of the universities which have conferred degrees on petitioners figured in the list - Held, these universities have acted beyond the limits provided by guidelines and Acts established for the purpose - Taking serious note of affairs of PRIST and other universities - Directions issued to State Chief Secretary to examine matter by conducting a thorough probe - Petitions held meritless and hence, dismissed; and

Whereas, in Imtiyaz Ahmad Bhat & Ors. Versus State & Ors 2012 (3) JKJ 258 the Hon'ble High Court of J&K held that and observed as:-Writ of mandamus - To accept and entertain degrees obtained through



DistanceMode from unrecognized universities - Sought by the petitioner commanding respondents to accept and entertain Degrees of Master of Science/M. Phil obtained through DistanceMode from unrecognized Universities for purposes of employment - Decision of State Higher Education Department pursuant to reference made by Public Service Commission that decision of the University in case of any disputed degrees shall be final - Decision not challenged in writ petition - Petitioners did not produce any document to show that their degrees are recognized in terms of University Grants Commission Act or any decision of J&K Higher Education Department - Writ petition dismissed in limine.

Whereas, in terms of Government Order No. 940-Edu of 2017 dated 17.11.2017, it is imperative upon the in-service candidate to pursue higher qualification after seeking proper permission from the competent authority at the relevant point of time.

Whereas, in Rabindra Nath Barman Vs Gauhati High Court, 2012 (2) GLT 111, it was held that the petitioner who has obtained degree in Law while serving in Gauhati High Court without proper authorization was held to be the misconduct because of which he was proceeded in departmental enquiry and the Gauhati High Court up-held it as a misconduct to undertake LL.B course without permission.

Whereas, in Nongmaithem Rejan Singh Vs State of Manipur, 2013 (1) GLT 7 it was held that if a person obtains graduation certificate without authorization, it amounts to misconduct and person who commits misconduct cannot be rewarded by promotion to the next higher post.

Similarly in the case of K.N. Pushpavalli Vs The Bar Council of Tamil Nadu WP (C) No. 46022/2002 (DOD Feb 26, 1013) reported in (2013) 3 MLJ 237, a full-time High Court employee, who, without getting prior permission from the High Court Registry and without intimating the Registry, joined three year Law Degree Course in SLSRC, Havanur College of Law, during academic year 1984-1987. According to her, she attended the Evening College by securing attendance during weekends and public holidays. On completion of the course, she was awarded Law Degree and the High Court, also, surprisingly, ratified the action of the petitioner in having joined the Law College at Bangalore, without intimating and without getting prior permission from the Registry. After superannuation, the said K.N. Pushpavalli, got enrolled before the Bar Council of Tamil Nadu on 02.05.2002 and subsequently, her enrollment was cancelled on 17.12.2002. Challenging the same, WP (C) No. 46022 of 2002 was filed and the same was dismissed on 26.02.2013 holding that the petitioner's enrollment was rightly cancelled as she was working in High Court of Madras during the period, during which she had alleged to have undergone the Law Course.

Whereas, it has been found from the records that the incumbents have obtained their degrees through distance mode which cannot be considered for the purposes of seniority and promotion or otherwise to the post of Lecturer in Environmental Sciences based upon the observations and deliberations made herein above.

Whereas, it has also been found that most of the incumbents have obtained such degrees without obtaining proper permission from the Competent Authority, as such the higher qualification acquired by the incumbents in contravention to the rules and regulations cannot be considered for the purposes of seniority and promotion or otherwise to the post of Lecturer



in Environmental Sciences based upon the observations and deliberations made herein above.

Therefore based upon the above observations, degree/s obtained through Distance Mode in Science Stream (Environmental Science/Ecology and Environment) cannot be considered valid for the purposes of seniority and promotion. Besides, in view of the above settled legal position, the degree obtained by the in-service candidate without obtaining proper permission from the competent authority cannot be reckoned valid particularly for the purposes of seniority and promotion.

In view of above facts and circumstances, the placements / postings in respect of 72 Masters/Teachers as in Annexure-A (61), Annexure-B (04), Annexure-C (03), Annexure-D (02) & Annexure-E (02) ordered vide Government Order No. 236-Edu of 2019 dated 15.07.2019, Government Order 252-Edu of 2019 dated 25.07.2019, read with Government Order No. 1071-Edu of 2022 dated 12.05.2022 and Government Order No. 325-Edu of 2019 dated 16.10.2019 are hereby withdrawn ab-initio. The incumbents are reverted back to their substantive posts and shall continue to be posted at the same place of posting against the available substantive post of Teacher/Master.
