In case adverse report is received against any of the officers from ACB / GAD (Vigilance), his/her assignment shall be deemed to have been cancelled ab-initio.
- The officer shall submit an undertaking to the concerned CEO stating that in case his/her service particulars / academic credentials are found fake / forged / tempered or issued by an unrecognized university, his/her assignment shall be deemed to have been cancelled ab-initio.
