Transfers and postings.

Government Order No: 66- Edu of 2015

Dated: 13-02 -

Whereas, vide Government Order No: 08-Edu of 2015 dated:15-01-2015, all the attachments/deployments of teaching staff viz. Lecturers/Masters/Teachers at any level were revoked and accordingly Director School Education, Jammu/Kashmir was directed to relieve the attached staff immediately for their original places of postings; and

Whereas, aggrieved by the above said order, some lecturers filed various writ petitions challenging the relieving order on the ground that Government order No: 08-Edu of 2015 dated: 15.01.2015 does not apply in their case as their posting does not fall within the ambit of attachment/deployment and therefore the impugned Government order cannot be pressed into service to relieve them from the present place of postings. Some other lecturers challenged the order for it being a blanket order without disclosing the grounds; and

Whereas, the Hon'ble High Court while disposing off SWP No: 173/2015

vide judgment dated: 23.01.2015 has directed as under:-

"Petition, in view of short controversy involved, is disposed of, with a direction to Commissioner/Secretary to Government, School Education Department, Civil Secretariat, Jammu to give a fresh look to the order impugned in the petition in the light of averments made in the petition and annexures appended thereto. Let such decision be taken by or before 22.02.2015. Petitioners on their part may make formal representation, if not earlier moved, to the respondent no. 1 or hand over copy of the petition with copies of its annexures to respondents to facilitate early disposal of the matter. Till 22.02.2015, the orders impugned in the petition shall not be acted upon and petitioners allowed to serve at present place of posting i.e. District Institute of Elementary Training (DIET), Jammu".

Whereas, similar orders have been passed in other writ petitions viz. 168/2015, 166/2015, 197/2015, 224/2015, 221/2015, 226/2015, 234/2015, 196/2015, 217/2015, 235/2015 & 289/2015; and

Whereas, it has been found that all the above lecturers were in excess of sanctioned strength of Institutions where they had been deployed and therefore were drawing their salaries against the overall cadre strength as there were no sanctioned posts against which their salary could be drawn in the respective institutions; and

Whereas, Government Order No.08-Edu of 2015 dated 15.01.2015 was intended to discontinue any arrangement, by whatever nomenclature, that had resulted in teaching staff continuing to remain in Jammu or nearby areas, beyond functional requirement and which had also resulted in non-posting of officials outside Jammu/ nearby areas causing vacancies in a number of schools in far flung areas and severely impacting the education of students; and

Whereas, the Government with a view to ensuring universal education has established schools at various locations including remote areas and has taken a series of measures to provide the required infrastructure and manpower to the schools but it has been observed that schools remain short of staff due to unwillingness of the staff to be posted out of Cities/ Towns; and

Whereas, an employee holding transferable post has no right to insist that he/ she should be allowed to serve at a particular post for a particular period since transfer is generally a condition of service and transfer from one place to another is necessary in public interest and efficiency in the public administration; and

Whereas, in terms of Rule 27 of Civil Services (Classification Control and Appeal Rules), 1956, a member of a service or class of a service may be required to serve in any part of the Jammu and Kashmir State in any post borne on the cadre of such service or class; and

Whereas, in light of the orders of the Hon'ble High Court, the matter has been re-examined by the Department in the above mentioned context and it has been found that Government order No: 08-Edu of 2015 dated: 15.01.2015 has been issued purely in the larger public interest.

Now, therefore, claim of the petitioners has been given a fresh look and it has been found that the same is not maintainable and therefore, in order to properly utilize the services of petitioners, in the interest of administration, the following transfers and postings of Senior lecturers/ lecturers are hereby ordered with immediate effect:-
