Whereas, a written complaint was lodged by the staff members of High School Gurdhan Bala against Shri Arun Kumar Gupta, the then I/c Headmaster, High School Gurdhan Bala (now attached with CEO, Rajouri), alleging misbehavior, non-drawal of salaries of staff, corruption, misappropriation of funds, unauthorized leaves/duties and even destroying the punctuality register at the end of every month, release of his own increment despite zero percent results and withholding the increments of other staff members, attempt to destroy service book of few staff members, drawing his own salary upto Sepetember, 2015 and for staff upto 6/2015, unauthorized tours in various institutions of Zone Rajouri and even misbehavior with female staff members; and

Whereas, Chief Education Officer, Rajouri vide his office Order No. CEOR/Gen/2015-16/15571-75 dated 07.10.2015, attached Shri Arun Kumar Gupta the then I/c Headmaster, High School Gurdhan Bala pending enquiry into the matter and, after conducting preliminary enquiry, submitted his report to Director School Education, Jammu; and

Whereas, Director, School Education, Jammu vide order No. 741-DSEJ of 2016 dated 09.01.2016 has constituted a three member committee for conducting detailed enquiry into the allegations of misbehavior, corruption and misuse of official position by Shri Arun Kumar Gupta I/C Headmaster and recommended his suspension on the basis of the preliminary enquiry.

Now, therefore, keeping in view of the above facts, pending enquiry into his conduct, Shri Arun Kumar Gupta I/C Headmaster, High School Gurdhan Bala, Rajouri, presently attached with CEO, Rajouri, is hereby placed under Suspension with immediate effect, in terms of Jammu and Kashmir Civil Service

(Classification, Control and Appeal) Rules, 1956. The officer, during his suspension period, shall continue to remain attached with the office of the Chief Education Officer, Rajouri.
