Subject: - Annual Transfer Drive (ATD-2022) of Lecturer Cadre – allotment of postings.

Notification No: 11 JK (Edu) of 2022

Dated: 06-05-2022

1. In response to Notification No: 1-JK Edu of 2022 dated: 09.02.2022, this Department has received online applications through a portal in subject Commerce under ATD - 2022.
2. Applications were scrutinized by software based developed system for the purpose in Phase-I as per criteria in ATD-2022 notification. The applicants were allotted their choice posting on the basis of criteria like disability, security ground, spouse, very hard and hard zone, extreme health condition etc. as in notification dated 09.02.2022 against actual and deemed vacancies.
3. It has been observed that some Lecturers having more than prescribed tenure and have not applied, however, they have been displaced due to choice of some eligible lecturers and have been placed in category of displaced lecturers.
4. It has been observed that some Lecturers having more than prescribed tenure have applied in ATD-2022 and they have not got their choice but have been displaced due to choice of some eligible lecturers, they have been placed in displaced category.
5. In case of 4, the displaced lecturers shall apply within stipulated time against the available choice vacancies; and in case of 5, the applicants shall apply again with their available choice vacancies as per notified procedure.
6. Further, in case of 4 and 5 above, the lecturers who have been displaced and those lecturers who have been posted against these displaced lecturers, shall continue to stay at their present place of posting till the posting orders of displaced lecturers are issued in Phase-II of the ATD 2022.
7. Accordingly, online applications are invited from these categories of displaced lecturers as per Annexure to this notification for consideration of their choice posting as per criteria in prescribed policy. They shall apply online in prescribed application format available at School Education Department website www.jkeducation.gov.in from 07.05.2022 to 14.05.2022.
