Sub: - Monitoring/Inspection of Schools by the Chief Education Officers; instructions thereof.

It has come to the notice of the Administrative Department that the Chief Education Officers (CEOs)/Zonal Education Officers (ZEOs) are not monitoring the regular activities of Schools falling under their jurisdiction(s), nor they are inspecting these School(s) with the result the functioning of the schools is suffering badly. It also affects the administrative efficiency at gross roots level.

In order to monitor/streamline functioning of the Schools, it is enjoined upon all the Chief Education Officers (CEOs)/Zonal Education Officers (ZEOs) to spare 3 days exclusively in a week to conduct the tour for inspection of School(s) falling under their jurisdiction(s). The concerned officer(s) shall furnish their inspection reports to the Director School Education of the respective Divisions on weekly basis.

Powers, if any delegated, earlier to the Principals of +2 level Schools to inspect the Schools shall and shall always be deemed to have been withdrawn ab-initio.

The above instructions shall be implemented in letter and spirit and any deviation on this account shall be taken very seriously. Action as warranted under rules shall be taken against the defaulting officer(s).
