Whereas vide Government Order No.402-Edu of 2011 dated 07.07.2011, among others, Shri Rajinder Singh, Senior Lecturer was elevated as I/C Principal & equivalent and adjusted as I/C Principal, HSS Sankoo (Kargil) against available vacancy; and

Whereas, it was also mentioned in the said Government Order that the officer elevated to the post of Principal & equivalent in-charge capacity shall report to his place of posting within 15 days from the date of issue of this order failing which he shall be treated to have foregone his elevation and his placement as I/C Principal & equivalent shall be treated to have been withdrawn ab-initio without any notice; and

Whereas from the above reveals that Shri Rajinder Singh, Senior Lecturer was required to join as I/C Principal, HSS Sankoo (Kargil) by or before 22.07.2011 but he had failed to join as I/C Principal; and

Whereas, after examination of the case in the Department, it has been decided to withdraw the elevation order of Shri Rajinder Singh as I/C Principal ordered vide Govt. Order No.402-Edu of 2011 dated 07.07.2011.

Now, therefore, it is hereby ordered that the promotion/elevation of Shri Rajinder Singh as I/C Principal & equivalent issued vide Government Order No.402-Edu of 2011 dated 07.07.2011 shall and shall be deemed to have been withdrawn ab-initio.
