Sanction is hereby accorded to the upgradation of 69 middle schools to the level of high schools under RMSA as per the annexure-A to this order subject to the fulfillment of following conditions:

The high schooling facility shall be within a reasonable distance of any habitation within a radius of 5 Kms away from the nearby high school.

The schooling facility is as per the requirement based on the number of children completing upper primary education upto a ceiling of 1 high school for every 5 2. middle schools.

The population within the 5 Krns shall not be less than 10000. The upgradation of upper primary schools shall be on the basis of habitation 3.
