1. The Institution is recognized and affiliated with the designated competent authorities and

also fulfill the conditions laid down in SRO123 of 2010.

2. The Chief Education officer Anantnag shall verify that the beneficiary Institutions is existing on the ground and is functional.

3. The Chief Education Officer Ananthag shall indicate in the sanction order componentwise break-up as per the DPRs.

4. The amount shall be spent in accordance with the guidelines of the scheme furnished by the concerned Ministry and no diversion shall be made to any other Scheme.

5. The CEO Anantnag shall send a status report about the physical and financial progress as per the schedule of Finance Deplt.

6. The funds are utilized for the purpose these are allotted for and utilization certificates are obtained and turnished to the concerned quarters.

FA/CAO shall vouchsafe utilization of funds as per the codal procedures

CEO shall furnish the details of funds (Grant-in-aid) if any released earlier to the Institution and communicate the same to concerned quarters.
