- (iii) the Drawing & Disbursing Officers concerned before fixing the pay of the Lecturer in the relvant pay scales as revised from time to time will obtain LPC and other related details (i & ii above) from the Drawing & Disbursing Officers of her parent Institutions.
- (iv) the regularization is without prejudice to the out come of any writ petition pending in any competent court (s) of law or any case pending in Vigilance or Crime Branch.

The Drawing & Disbursing Officers shall be responsible for implementation/fulfillment of above conditions in letter and spirit.
