Whereas, the updated/ final seniority list of PG Masters/ Teachers in the discipline of **Music** was issued by this Department vide Government order No.400-Edu of 2013 dated 30.03.2013; and

Whereas after issuance of the said seniority list, Director School Education, Jammu has furnished the service particulars of Smt.Anjana Kumari, Master alongwith her representation for re-fixation of her seniority on the basis of her promotion as Master in the updated seniority list issued vide Govt. Order No.400-Edu of 2013 dated 29.03.2013; and

Whereas, on examination of updated/ final seniority list in the discipline of Music, it has been found that the name of Smt.Anjana Kumari, was figuring at Srty No.5 as teacher though she was elevated as Master giving the effect from 06.07.2011 and her entry as Master needs to be incorporated in the updated seniority list of PG Masters/ Teachers in the discipline of Music; and

Whereas, the case was examined in this department and on the basis of her service bio-data forwarded/ authenticated by the DSE Jammu a notice was issued through print media vide Notice No.Edu/V/56/2013 dated 29.08.2013 for inviting objections with regard to re-fixation of her seniority in the discipline of Music and in response to that no objection was received in this department within the stipulated period mentioned in the notice; and

Whereas an exercise has been made as per rules in vogue on the subject and on the basis of following service particulars forwarded & authenticated by Director School Education, Jammu, Smt.Anjana Kumari, Master and as such her seniority has to be fixed at Srty No.3-A instead of 5 considering his elevation as Master and accordingly her seniority needs to be re-fixed in the updated/ final seniority list of PG Masters/ Teachers in the discipline of Music issued vide Govt. Order No.400-Edu of 2013 dated 29.03.2013:-
