WHEREAS, the petitioners figuring in Contempt Petition No. 265/2014 in SWP No. 54/2014 titled Mohammad Afzal Chopan and Ors Vs UT of J&K and Ors were placed as I/c Lecturers in the discipline of Environmental Science vide Government Order No: 236-Edu of 2019 dated 15.07.2019 & similarly petitioners figuring in Contempt Petition No. 568 of 2021 in SWP No. 1507 of 2014 titled Zahoor Ahmad Rather and Ors. Vs UT of J&K and Ors were placed as I/c Lecturers in same discipline vide Government Order No: 252-Edu of 2019 dated 25.07.2019 & Government Order No: 325-Edu of 2019 dated 16.10.2019; and

WHEREAS, among other conditions, the above placement was subject to the condition that "the Director, School Education Kashmir/Jammu shall verify the Post Graduate degrees obtained during service through distance mode in light of the Government Order No. 940-Edu of 2017 dated 17.11.2017 and shall allow such Masters to join only when/if the PG degrees are found genuine"; and

WHEREAS, Director, School Education, Kashmir vide communication No. DSEK/PGMT-PF/458 dated 17.10.2018 & No DSEK/PGMT-PF/202 dated 09.07.2019 forwarded the verification reports of PG Degree certificates in respect of the petitioners stating that the bonafide certificates in respect of the petitioners have been issued by the Deputy Director, Sikkim Manipal University, Directorate of Distance Education, Gangtok Sikkim and fulfill the conditions as laid down in the Government Order No. 940-Edu of 2017 dated 17.11.2017; and

WHEREAS, the posting/adjustment order in favour of the petitioners could not be issued as the Department had taken up the matter with Higher Education Department for clarification regarding equivalence of Master's Degree in Environmental Science with that of Master's Degree in Ecology and Environment as required in light of Government Order No. 252-Edu of 2012; and

WHEREAS, the Hon'ble High Court of Jammu and Kashmir and Ladakh and Ore Vs Mr. B.K Singh and Ors, which is reproduced as under:

"On the last date of hearing, Ms. Asifa Padroo, learned AAG appearing for the respondents had sought ten days time to file latest status report after conveyed to the School Education Department by Higher Education the order of the writ Court has been complied with.

In view of the above, it is directed that in case order of the writ court is not complied by or before next date of hearing, Commissioner/Secretary to the Government, School Education Department, shall appear in person before this Court."

WHEREAS, the Hon'ble High Court of Jammu and Kashmir and Ladakh passed another Order dated 06.04.2022 in CCP (S) No. 568/2021 titled Zahoor Ahmad Rather and Others Vs Mr. Bishwajit Kumar Singh and another, which reads as under:-

"Learned counsel for the petitioners submits that a similar contempt petition is listed for consideration on 25.04.2002, and, therefore, it would be appropriate if this contempt petition is also taken up with CPSW No. 265/2014.

On the request of learned counsel, list along with CPSW No. 265/2014 on 20.04.2022.

Meanwhile, the respondents shall file statement of facts/compliance report by the next date."

WHEREAS, after receipt of above orders from the Hon'ble High Court, the case was further examined in the Department and it was decided to take up the matter with the Department of Law, Justice & Parliamentary Affairs for seeking their opinion.

WHEREAS, Department of Law, Justice & Parliamentary Affairs, while returning the departmental file vide U.O. No. Law-Lit4/499/2022-10, dated 18.04.2022, opined as under:-

"Returned. The proposal regarding posting of petitioners, who stand already promoted as I/C Lecturers on the basis of Court Orders is agreed to, enabling the department to file a compliance report well before the due date i.e., 20.04.2022. The Department is also advised to simultaneously complete the process of verification of documents and shall also ascertain that these degrees are UGC recognized."

WHEREAS, in the meantime, the Hon'ble High Court of Jammu and Kashmir and Ladakh passed Order dated 20.04.2022 in CPSW No. 265/2014 c/w CCP No. 568/2021 titled Mohammad Afzal Chopan & Ors Vs Mr. B.K. Singh & Ors, which reads as under:-

"Learned counsel appearing on behalf of respondents submits that the matter is under active consideration and seeks, further time to file the compliance report. Compliance report be positively submitted within a period of fifteen days failing which, respondents no. 1, shall appear in person on the
