Whereas, among others, one Sh. Zakir Hussain was placed as I/C Lecturer in the discipline of Sociology vide Government Order No. 366-Edu of 2019 dated 24.10.2019;

Whereas, the Director School Education, Jammu vide communication No. DSEJ/Gaz/Lect/1000/2020/4331 dated 22.02.2020, intimated that in the above said Government order the date of promotion as Master of Sh. Zakir Hussain has been shown as 08.01.2007, however, the actual date of promotion as Master as per his service book is 04.08.2007;

Whereas. Sh. Zakir Hussain submitted a representation before the School Education Department seeking redressal of his grievances;

Whereas, Sh. Zakir Hussain approached the Hon'ble Central Administrative Tribunal, Jammu Bench, Jammu through O.A No. 61/779/2020 titled Zakir Hussain Vs UT of J&K and others and prayed for the following relief:-

 Commanding the respondents to decide the pending representation filed by the applicant on 10-08-2020 by passing a well reasoned and speaking order communicate the same thereafter to the applicant.

Whereas, the the Hon'ble Central Administrative Tribunal, Jammu Bench, Jammu on 16.09.2020, was pleased to pass the following order:-

"O.A is disposed of with a direction to the respondents to consider and dispose of the representation filed by the applicant along with letter dated 22.02.2020 addressed by Director School Education, Jammu to Commissioner, School Education Department, Civil Secretariat, Jammu by passing a reasoned and speaking order within the period of one month from the date of receipt of certified copy of this order with intimation to the applicant".

Whereas, the representation of the applicant has been examined in the Department and found that the placement was made as per his date of promotion as Master, i.e 08-01-2007 while as his actual date of promotion as Master is 04-08-2007;

Now, therefore, the claim of the applicant has been considered in light of the directions passed by the Hon'ble Central Administrative Tribunal, Jammu Bench, Jammu on 16.09.2020 and communication No. DSEJ/GAZ/Lect/1000/2020/4331 dated 22-02-2020 of Director School Education, Jammu, and the correction in the date of promotion as Master of the applicant has been rectified as 04.08.2007 instead of 08.01.2007.
