Whereas, Sh. Vinod Bhat and Rekha Koul Bhat filed OA applications before the Hon'ble Central Administrative Tribunal, Jammu and have sought following relief in the matter:-

- A. That the Respondent No. 1 to 4 may kindly be directed and commanded to consider the case of the Applicants for transfer from Government Middle school Nandigund and Government Middle School, Raj Bagh (District Srinagar) to the Migrant cell Jammu, on the analogy, whereby, sanction was accorded to the Deployment of Mr. Rakesh Raina and Mrs. Urmila Pandita (PM's package) Teachers, posted in District Kupwara to Migrant Cell Jammu, keeping in view the physical disabilities being suffered by her while appreciating the provisions of the Persons with Disabilities (Equal Opportunities, Protection of Rights and Full Participation) Act, 1995 which has recognized the right of access for the disabled people to education and vocational training, employment practice, travel on public transport and mobility schemes, barrier free environmental and integrated living independence and dignity.
- B. That the Respondents No. 1 to 4 may kindly be directed and commanded to take a sympathetic and consider view for transfer for the Applicants from Government Middle School Nandigund and Government Middle School, Raj Bagh (District Srinagar) to the Migrant cell Jammu on the analogy whereby sanction was accorded to the deployment of Mr. Rakesh Raina and Mrs. Urmilla Pandita (PM's Package) Teachers posted in District Kupwara to Migrant cell Jammu keeping in view the physical disabilities being suffered by her while appreciating the provisions the Persons with Disabilities (Equal Opportunities, Protection of Right and Full Participation) Act, 1995.

Whereas, the Hon'ble Central Administrative Tribunal vide its order dated 02.03.2022 passed in O.A.No.61/188/2022 titled Vinod Bhat V/s UT of J&K & Ors disposed of the OA with the following directions:-

"Looking to the limited prayer made by the learned counsel for the applicants the OA is disposed of with direction to the respondents to dispose of the representation dated 22.11.2019 by passing a reasoned and speaking order within period of two weeks from the date of receipt of a certified copy of this order the respondents would also consider the contents of the O.A while disposing of the representation of the applicant. A copy of the speaking order be communicated to the applicant."

Whereas, in pursuant to the order dated 02.03.2022, passed by the Hon'ble Central Administrative Tribunal, Jammu as well as representation dated 22.11.2019 filed by the father of the applicants namely Sh. Vinod Bhat, Teacher Government Middle School Nandigund and Rekha Koul Bhat, Teacher Government Middle School, Raj Bagh (District Srinagar) which has been examined in the Department and it has been found that Sh. Vinod Bhat is handicapped and have a disability of 50% as per Certificate of disability issued by Chief Medical Officer, Health, Jammu. Further, wife of applicant Rekha Koul Bhat is also handicapped and have a disability of 45% as per Certificate of disability issued by Social Welfare Department.

Whereas, both the teachers are physically challenged which is also certified by Chief Education Officer, Srinagar vide his letter dated CEO/Sgr/Est/20205823 dated 15..07.2020;

Now, therefore, in view of the above, the claim of the applicant has been considered in light of the directions passed by the Hon'ble Central Administrative Tribunal, Jammu on 02.03.2022 in O.A No. 61/188/2022 titled Vinod Bhat V/s UT of J&K & Ors and on the basis of disability certificate issued by Chief Medical Officer, Health, Jammu, sanction is hereby accorded to the deployment of Mr. Vinod Bhat, Teacher, MS Nadirgund, and Rekha Koul Bhat, Teacher Government Middle School, Raj Bagh (District Srinagar) to the Migrant Cell Jammu for a period of one (1) year. The officials shall however, retain his/her lien, seniority and promotion prospectus in his/her parent district cadre viz. District Srinagar. The officials shall report to the Directorate of School Education, Jammu for further duties.


