Quashing the Government Order No. 1455-JK(Edu) of 2021 dated 24.09.2021 issued by the respondent No. 1 by virtue of which the applicant has been transferred from DIET, Rajouri to HSS Chingus, Rajouri

Commanding upon the respondents to decide the representation of the applicant with regard to modification of the Government Order No. 1455-JK(Edu) of 2021 dated 24.09.2021 in respect of her adjustment from HSS Chingus to HSS Mohalia Kassaban Jammu on available vacancy on medical grounds.

Whereas, the Hon'ble Central Administrative Tribunal Jammu vide its order dated 31.03.2022 disposed of the O.A of the applicant with the following directions:-

"On considering the above submissions of counsels for the parties, this O.A. is disposed of at admission stage, without expressing any opinion on merits of the case, directing Respondent No. 1 to decide the pending representation of the applicant dated 19.07.2021 in view of her health grounds as per provisions of transfer policy and decide it with a speaking order within four weeks from the date of receipt of a certified copy of this order and within one week thereafter to communicate it to the applicant. No costs",

Whereas, the representation of the applicant was examined in the Department and found that the post of Lecturer is a UT cadre post and the UT cadre Officer is required to serve in any part of the Union Territory of J&K upon Administrative requirement of the Government and as such cannot insist upon posting at a particular place of his choice;

Whereas, in terms of Rule 27 of Classification Control and Appeal Rules, 1956, a member of a service or class of a service may be required to serve in any part of the Union Territory of Jammu and Kashmir on any post borne on the cadre of such service class.

Whereas, the issue of transfer and postings has been considered time and again the Hon'ble Supreme Court, and the entire law is settled by catena of decisions of the Apex Court. It is settled law that transfer of a Government servant appointed to a particular cadre of transferable post from one place to the other is an incident of service. No Government servant, therefore, has any legal right for being posted at any particular place. Moreover transfer from one place to another is necessary in public interest and existency in public administration as held in "Gujrat Electricity Board Vs Atma Ram Surjomal Poshani", AIR 1989 SC 1433, which reads as under:-

"An employee holding a transferable post cannot claim any vested right to work on a particular place as the transfer order does not affect any of his legal rights and Court cannot interfere with a transfer/posting which is made in public interest or on administrative exigency."

Whereas, the Hon'ble High Court of Jammu and Kashmir at Jammu vide its jud ment dated 18.05.2018 passed in SWP No. 891/2018 titled Shivani Manhas Vs State of J&K and others has held that the transfer of an employee is the mandate of the employer and an employee can be transferred at any place keeping in view the administrative exigency;

Whereas, a Division Bench of the Hon'ble Supreme Court while dismissing a Special Leave Petition (SLP) vide its judgment dated 06.09.2021 has passed the following:-

"It is not for the employee to insist to transfer him/her and/or not to transfer him/her at a particular place. It is for the employer to transfer an employee considering the requirement,"

Whereas, the applicant has been posted as I/C Lecturer, HSS Chingus, Rajouri, which is only few Kms from Rajouri City and as such she can avail medical facilities at her place of posting i.e., HSS Chingus. Further the nature of medical condition in no way prevention employee from discharging his/her duties.
