On the basis of seniority and eligibility, Principals & equivalent as indicated in Annexure-"A" to this order are hereby placed as I/C Chief Education Officers & equivalent in their own pay and grade with charge allowance as admissible under rules for a period of six months or till the posts are filled-up on regular basis whichever is earlier. These placements, however, will not confer any superior claim or right upon them at the time of confirmation under rules and shall also be subject to the outcome of case(s) pending adjudication, if any, in court of law. However, with regard to the categories other than open merit, the claim of the superior shall be considered, if any, by demoting the junior one.

Consequent upon above, the transfers/posting and adjustments of I/C Chief Education Officers & equivalent as indicated in Annexure-"B" to this order are hereby ordered with immediate effect.


