Subject: Re-fixation of seniority of +2 Lecturers (Urdu) of School Education Department

NOTICE

Whereas, vide Government Order No.127-Edu of 2020, dated 26.05.2020, final seniority list of PG Masters/Teachers in the discipline of Urdu was issued. Thereafter, a request has been received from Mr. Mohd Zabir, Retired I/c Lecturer in the discipline of Urdu, wherein he has requested for correction of his date of promotion as Master as **15.04.2005** instead of **16.05.2005** as shown in the final seniority list of PG Masters / Teachers in the discipline of Urdu notified vide Government Order No.127-Edu of 2020, dated 26.05.2020, in which the incumbent figured at S.No.162.

Whereas, the case has been examined and it was found that the grievance of the said official is genuine and accordingly vide corrigendum dated 04.04.2022 issued under endorsement No. Edu/HRM/93/2022-01 dated 04.04.2022, necessary correction in the date of promotion as Master of the said official in the final seniority list of PG Masters/Teachers in the discipline of Urdu issued vide Government Order No. Government Order No.127-Edu of 2020, dated 26.05.2020 has been made.

Whereas, after rectifying the date of promotion as Master of the said incumbent, the seniority position of the said official shall also be changed, which needs to be rectified in the final seniority list of PG Masters/Teachers in the discipline of Urdu.

Whereas, after examining the service particulars of said incumbent as received from Director School Education Jammu, the revised seniority position of the official shall be as under:-

Now, therefore before fixing/re-fixing seniority in respect of the above mentioned incumbent in the final seniority list of +2 Lecturers issued vide Government Order No. Government Order No.127-Edu of 2020, dated 26.05.2020, the concerned members of the service/cadre who are likely to be affected by assigning him appropriate place are hereby called upon to submit their objections, if any, with the service particulars along with authenticated documentary proof, directly to the School Education Department within a period of 07 days from the date of issuance of this notice through print media.

Objections, if any, in this regard will not be entertained after expiry of the stipulated period. In case no objection is received within the stipulated period, it shall be presumed that no member of the cadre has any objection and necessary orders will be issued accordingly.
