Whereas, Smt. Raj Kumari, Lecturer (Physics) represented this department for re-fixation of her seniority in the cadre of +2 Lecturer on the basis of her regularization effected from 17.09.1992; and

Whereas, vide Government Order No. 350-Edu of 2003 dated 31.03.2003 combined updated Seniority list of +2 Lecturers of School Education Department was issued whereunder Smt. Raj Kumari Lecturer (Physics) is figuring at seniority No.1864 on the basis of her date of earlier regularization i.e 31.08.1995; and

Whereas, the case of the Lecturer has been examined in the department and it has been observed that in view of change in the date of regularization of Smt. Raj Kumari, Lecturer (Physics) w.e.f 17.09.1992 on notional basis, she shall now figure at Seniority No.1401-A i.e in between Nishi Kala Koul (Seniority No.1401) and Ajeet Sharma (Seniority No.1402) in the combined Final Seniority List of +2 Lecturers of School Education Department issued vide Government Order No.350-Edu of 2003 dated 31.03.03.
