Whereas, vide Government Order No.102-Edu of 2018 dated 29.01.2018, Sh. Hem Raj, Lecturer (Commerce) was regularized as Lecturer w..e.f 09.11.1995 on notional basis and regular basis from 29.02.2004; and

Whereas Sh. Hem Raj, Lecturer (Commerce) represented this department for re-fixation of his seniority in the cadre of Lecturer on the basis of his regularization effected from 29.02.2004; and

Whereas, vide Government Order No.1073-Edu of 2013 dated 30.12.2013 combined updated Seniority list of +2 Lecturers of School Education Department was issued where under Sh. Hem Raj Lecturer (Commerce) is figuring at seniority No.741 on the basis of his earlier date of regularization; and

Whereas, the case of the Lecturer has been examined in the department and it has been observed that in view of change in the date of regularization of Sh. Hem Raj, Lecturer (Commerce) as 09.11.1995 on notional basis, he shall now figure at Seniority No.1986-A i.e in between Roshan Ara (Seniority No.1986) and Satinder Kour (Seniority No.1987) in the combined Final Seniority List of +2 Lecturers of School Education Department issued vide Government Order No.350-Edu of 2003 dated 31.03.2003.
