



- 1) **Whereas**, the Services Selection Board forwarded a select list of candidates for the post of Teacher (Education Department) in pursuance to Advertisement Notification No. 05 of 2013, under Item No. 483, (District Cadre Kathua) to School Education Department vide No. SSB/Sel/Secy/2015/9197-9204 Dated 07-09-2015 for further course of action ;and
- 2) **Whereas**, petitioner had applied for the post of Teacher District Cadre Kathua pursuant to Advt. No. 05 of 2013 dated 02.03.2013 under RBA category and on the basis of her merit position made it to the S.No.62 of the selection list under RBA category, but the recommendation was kept withheld subject to the production of valid category certificate.
- 3) **Whereas**, the last date for submission of application forms was fixed as **06.04.2013** and the petitioner has submitted all relevant documents along with the two RBA category certificate, which was issued by the Tehsildar Billawar probably on the count that the RBA certificate was to be renewed after every 05 years and the case/representation of the petitioner was under examination in the Board ; and
- 4) **Whereas** , Petitioner approached Hon'ble High Court through the medium of SWP No. 26/2016 and sought direction to the respondents to recommend the candidature of the petitioner for the post of Teacher district cadre Kathua vide Advt. notification no. 05 of 2013 dated 02.03.2013 under RBA category against which the petitioner has become entitled to be appointed by operation of waiting list notified by the respondents; and
- 5) **Whereas**, the above said writ petition was finally disposed of by the Hon'ble court vide judgment order dated 05.06.2018 and the operative part of the judgment is reproduced as under:

"... Accordingly, this petition is allowed and respondent No. 04 is directed to recommend the candidature of the Petitioner to respondent No.01 to 03 for issuing appropriate





