In continuation to this Department's letter of even number dated 23.04.2018 regarding the subject cited above, I am directed to forward herewith a copy of letter No. SSB/Sel/Secy/2018/180-82 dated 14.01.2020 and request you to treat the withheld recommendation of the candidate namely Surita Devi D/o Romesh Singh R/o Deon Bari Brahmana, figuring at Sr.No. 01/RBA/wait against the post of Teacher, District Cadre Samba, item No. 154, as released and operate wait list/issue appointment orders in her favour against the vacancy accrued due to the cancellation of the withheld selection of candidate namely Jameet Singh S/o Partab Singh R/o Deon Samba, figuring at Sr.No. 08/RBA by the Services Selection Board, against the post of Teacher, District Cadre Samba, item No. 154. The appointee shall be, however, allowed to join only after fulfillment of all the codal formalities and the appointment shall be subject to the following conditions:-

- i) The appointee/selectee shall be on probation for a period of two years.
- ii) The appointees shall be governed under New Pension Scheme as per SRO 400 of 2009 dated 24.12.2009.
- iii) In case, at any stage it emerges that the certificates/any relevant document furnished /produced by the selectee is/are fake/fictitious, the appointment order shall be cancelled ab-initio and criminal proceeding shall be initiated against the candidate.
- iv) The selectee shall give an undertaking by way of affidavit duly attested by the 1st Class Judicial Magistrate to the effect that they will not apply for transfer in any case where he/she have been adjusted/posted.
- v) The appointment of the candidates shall be subject to outcome of any writ petition(s), if any, pending in any court of competent jurisdiction.


