SRO 125 : - In exercise of the powers conferred by proviso to Section 124 of the Constitution of Jammu and Kashmir, the Government hereby makes the following amendment in Jammu and Kashmir School Education (*Subordinate*) Service Recruitment Rules, 2008 namely:-

		ii) Teacher Grade-II	Level-5 Rs.29200- 92300 w.e.f 01.09.2018	Graduate from any recognized University. Preference will be given to the candidates possessing B.Ed or M.Ed. or Masters Degree.	

*The Cadre of 'Teacher Grade-II' is created exclusively for the purpose of adjusting RReTs. It shall constitute a distinct cadre till all the eligible RReT, transited to the post of Teachers Grade-II, vacate these posts due to resignation, superannuation, death, promotion or otherwise. Consequently, the cadre of Teacher Grade-II will stand abolished automatically after the last incumbent vacates the post.
