Placement of I/C Headmasters & equivalent as I/C Zonal Education Officers & equivalent. Transfers and Postings thereof.

Government Order No: 606 -Edu of 2012 D a t e d : 27 - 07 - 2012

On the basis of seniority and eligibility, the officers detailed in Annexure-"A" to this order are hereby placed as I/C Zonal Education Officers & equivalent in their own pay and grade with charge allowance as admissible under rules for a period of six months or till such time the posts are filled-up on regular basis whichever is earlier. These placements, will, however, not confer any superior claim or right upon them at the time of regularization and shall be subject to the outcome of any case pending adjudication in any court(s) of law. The incumbents elevated under any reservation category shall be demoted in case of any superior claim.

Consequent upon above, transfers and adjustment of I/C Zonal Education Officers & equivalent as indicated in the Annexure "B" to this order are hereby ordered with immediate effect.

The Officers elevated to the post of Zonal Education Officers & equivalent in incharge capacity shall report to their places of posting shown against each within 15 days from the date of issue of this order failing which he/she shall be deemed to have foregone his/her elevation and his/her placement as I/C Zonal Education Officers & equivalent shall be treated to have been withdrawn ab-initio without any notice.

The Officers already working against the post of I/C Zonal Education Officers & equivalent and transferred consequent upon the placement of promotees shall also report at their new place of posting immediately.
