Whereas, the petitioner Mohd Yaqoob filed the above titled writ petition before the Hon'ble High Court.

Whereas, the Hon'ble High Court Jammu vide order dated 25.07.2013 disposed of the SWP with following directions:-

"This petition is disposed of by providing that the respondents shall accord consideration to regularization of petitioner as Head Master as per rules governing the field and such consideration order shall be passed within one month from the date copy of this order is made available to the respondents."

Whereas, pursuant to the directions of the Hon'ble High Court Jammu, the representation of the petitioner was examined in the Department and it was found that vide Government Order No. 684-Edu of 2012, dated 04.09.2012, regularization order of 2529 Masters (worked / working as I/c Headmaster and equivalent) as Headmaster & equivalent was issued and regularization was done strictly in terms of seniority/availability of posts and reservation rules. The petitioner has not been regularized as Headmaster due to the fact that the post was available on 01.02.2007 and he retired on 31.08.2006 before accrual of vacancy. Moreover, his senior/junior counterpart having seniority No. 1642 and 1644 were regularized as Headmaster w.e.f. 01.02.2007.

Keeping in view the facts and circumstances of the case and in compliance to the directions of the Hon'ble High Court passed in SWP No. 1596/2013 titled Mohd Yaqoob Vs State of J&K & others, the claim of the petitioner has been considered and being not tenable under rules is hereby rejected.
