Subject: CP No. 252/2022 in OA No. 61/605/2022 titled Ahsan-ul-Haq V/s
UT of J&K & Ors.

Whereas, the applicant has filed OA before the Hon'ble Central Administrative Tribunal Jammu and has prayer for the following reliefs in the matter:-

- i. The non-applicants be directed to promote/place the applicant to next higher post i.e. Lecturer/incharge in the discipline of Economics on the same analogy and Principal as has been adopted in case of other similarly situated and juniors of the applicant and to release all the consequential benefits flows out same in favour of the applicant.
- ii. Further direction thereby directing the non-applicants to update the seniority list of PG Masters/Teachers in the discipline of Economics and bringing the name of the applicant at its appropriate place in the seniority list for grant of further service benefits as accrued and admissible under rules.

Whereas, the Hon'ble Central Administrative Tribunal Jammu vide order dated 01.07.2022 has disposed of the OA application with the following directions:-

"On consideration of the above submission of the counsels for both the parties, this O.A is disposed of at admission stage, without expressing any opinion on merits of the case, directing the respondents to consider a copy of this OA as representation of the applicant as per provisions of relevant rules and binding instructions for placement of Masters as In-Charge Lecturers and decide it with a reasoned order within four weeks from the date of receipt of a certified copy of this order and then communicate it to the applicant."

Whereas, the applicant has also filed contempt petition bearing No. CP No. 252/2022 before the Hon'ble Central Administrative Tribunal Jammu.

Whereas, in pursuant to the directions of the Hon'ble Central Administrative Tribunal Jammu the case of the applicant was examined in the department and found that vide Government Order No. 2070-Edu of 2022, dated

16.08.2022 final seniority list of PG Masters/Teachers in the discipline of Economics was issued and the applicant Mr. Ahsan-ul-Haq is figuring at Serial No. 52 of the said list. As and when further placements/promotions in the discipline of Economics are made, the applicant shall also be considered strictly on the basis of his seniority/merit.

Keeping in view, the facts and circumstance of the case and in compliance to the directions of the Hon'ble Central Administrative Tribunal passed in OA No. 61/605/2022 titled Ahsan-ul-Haq Vs UT of J&K and others, the claim of the applicant is considered and is directed to be placed for promotion in the next DPC strictly as per their eligibility and seniority.
